FTEE Practical Examination Guidelines

- **Eligibility:** Only those candidates, who pass the FTEE theory exam 2024 and have their CDL approved, are allowed to take the FTEE practical exam.
- **Submission of Case distribution logbook (CDL):** Candidates who pass the theory exam and not submitted the CDL must submit the CDL of 100 cases, including 25 cases with loops and images. The final logbook presented during practical exam should have the cases listed in CDL as submitted to ICCA. This CDL should have the following columns: Sr. No., hospital/institute registration number of patient, date of case conducted, clinical diagnosis, and name of person/persons who performed echocardiography. The supervisor (mentor/head of the department /division or institute) should sign each page of CDL. This CDL should accompany a cover letter where the candidate writes each case category's total number of cases. The candidate and the supervisor must also sign the cover letter. The distribution of a total of 100 cases, as well as the distribution of 25 video cases, should be as per the guidelines prescribed and posted on the IACTA website.

Those Candidates who pass the theory exam and not submitted the CDL must submit the CDL by 31st October at the latest. The CDL should be sent in scanned PDF format to iccaregistrar@gmail.com by email.

The CDL will be screened by the FTEE exam board (core committee for FTEE exam) and the final decision will be communicated to the candidate by the ICCA registrar. The candidate whose CDL is not up to the mark as prescribed in the "Case distribution for log book" published on the IACTA website, will not be allowed to take the practical exam. If they wish, they can update the CDL and send it within time (31st October 2024) to become eligible for the practical exam. A candidate who does not have an approved CDL by 31st October will not be allowed for the practical exam, despite the fact that he/she has passed the theory exam. They must appear for the theory exam afresh next year and complete the same process for next year.

The candidates who have added or changed more than 20% of cases in their previously approved logbook, need to submit the CDL again for approval.

Those candidates whose CDL is approved but fail in practical must take the theory exam again and submit the CDL as fresh candidates next year.

- **Eligibility to appear for the FTEE practical exam:** A candidate who has passed the theory exam and those who failed in the August session or did not appear or did not opt for the August session is eligible for FTEE practical exam, December 2024.
- **FTEE Practical exam:** Those candidates who have passed the FTEE theory exam will be eligible to take the FTEE practical exam December session (scheduled on 6th, 7th & 8th of December 2024). The exam center for the practical exam will be announced well in advance. The exam fee is Rs.6000/- for every attempt of the practical exam. Those who failed in the August session or did not appear or did not opt for the August session, can appear for the December session of the practical exam. Those who do not pass the practical in August and thereafter in the December session need to start afresh next year.

Pattern of the FTEE Practical Examination

- The practical exam consists of two tables of grand viva (50 marks each), two examiners at simulator-based evaluation (50 marks each), and two examiners at the logbook section (50 marks each). Thus, the total practical exam would be 300 marks, and the candidate needs to score 150 or more to "Pass" the practical exam.
 - **Grand viva:** This would include interpreting echo pictures and loops (mainly transesophageal, but trans thoracic and epicardial/epiaortic echo/3D echo also may be asked).
 - **Simulator:** Evaluation of hands-on TEE simulation will be done by two examiners. Evaluation will mainly be based on probe handling, getting desired images and interpretation. Simulator would have 2D TEE probe.
 - **Logbook:** The logbook will be presented by the candidate with the same cases as submitted in CDL. The evaluation of the reported 100 cases, along with the media files of 25 video cases (out of the same 100 cases), would be done. The candidate should bring the logbook along with the 25 cases of media files in a power point format on a DVD/ pen drive or laptop to be presented before the examiners. The logbook format and TEE report form are available on the IACTA website.
- **Cancellation and refund of fee:** Candidates who do not appear for the examination will forfeit the exam fee except under exceptional circumstances. Students who paid the fee but could not appear for the exam, and wish a refund must write to the ICCA office with valid proof or a medical certificate, which the ICCA office will verify. The decision of the ICCA office regarding a refund carry forward to next session (only for August session requests to be carried forward to December session of same year) or forfeit of the fee paid will be final.

- **Re-evaluation of the result:** One can apply for re-evaluation within one week of the publication of the result. The re-evaluation request should be sent to iccaregistrar@gmail.com. The Dean Exam will go through the re-evaluation process (only the total of the marks obtained in each section). The dean exam will present the report to the ICCA registrar and will be presented for approval to the ICCA board. The board's decision would be final and cannot be further challenged at any platform in IACTA.
- **Publication of the result:** The fellowship awardee list will be published on the website after both the practical exam results are declared.
- **IACTA Belani Award:** The highest scorer of the FTEE theory and practical combined will be awarded the "IACTA Belani Award."
- **Award of fellowship certificates:** The fellowship will be awarded during the inauguration ceremony during the coming IACTA annual conference.
- **Duration of validity of FTEE fellowship:** The FTEE fellowship is for 10 year period from the year of award of FTEE.
