# FIACTA (Paed) Examination: guidelines

1. Candidate must be a life member of IACTA and should have completed the one year pediatric fellowship course in recognized centers. Life membership form is available at [www.iacta.co.in](http://www.iacta.co.in)
2. The Examination fee for FIACTA (Paed) is Rs.15,000/-. Candidates who register for the examination and do not appear will forfeit the examination fee. Fee for second or subsequent attempts is also Rs.15,000/-. Students who do not appear due to medical reasons will have to pay Rs 6000 at the next attempt. However, the candidate should produce a medical certificate which should be forwarded by HOD. The final decision will be taken up by the ICCA office.
3. Those who have passed DM/DNB Cardiac Anaesthesia can apply directly for FIACTA (Paed) examination by paying the examination fee of Rs15,000/-with a registration fee of only Rs 2000.
4. Completed forms to be sent to the ICCA office along with information of mode of payment. Candidates will receive confirmation of receipt of the examination form (and Life membership if applied) from ICCA office once the payment has been confirmed.
5. Log book of 50 cases, certified by the Head of Department or Mentor. For HODs self-certification is acceptable. The format of log book is given on the website. The log book of FIACTA (Paed) students to be countersigned by the head of the institution. Those appearing after completion of DM/DNB Cardiac Anaesthesia need to submit their course log books only.
6. Syllabus of FIACTA (Paed) can be downloaded from the website [www.iacta.co.in](http://www.iacta.co.in)
7. For passing the examination, candidate is required to score 50% marks in both theory and practical.
8. Dates of examination: Second Saturday & Sunday of August every year. The exact dates can be confirmed from the website / ICCA office.
9. Last date for application is two months before the examination; last date for cancellation is one month before the examination.
10. Accommodation will be made available for 2 days (exam days) on payment.
11. The eligibility of the candidate will be verified by the ICCA office before the application is accepted and the candidate is allowed to appear for the examination.
